(9) Evidence of Registration on National Database of Contractors, Consultants and Service Providers by inclusion of Interim Registration Report (IRR) from BPP expiring 31st December, 2018.

(10) Evidence of payment of Tender Fee indicating the chosen lot;

(11) Verifiable and documented evidence of award and successful completion of, at least, two
(2) similar contracts within the last five (5) years stating the scope, value, location and referral contact and telephone number.

(12) List of equipment to be used for the projects stating whether owned, to be hired or leased with evidence of ownership, lease agreement or hire for construction works.

(13) Company's registered address, functional address, GSM phone number and e-mail address.

(14) Company's banking detail, including Account Name, Account Number, Bank Name, Branch and Sort Code.

(4.0) TENDER FEES

A non-refundable tender fee of N10,000.00 (Ten thousand Naira only) per Lot is to be paid by each bidder before collection of a Standard Bidding Document. The tender fee should be paid into the TSA account No.0160099561014 in favour of Federal College of Agriculture, Akure.

(5.0) COLLECTION OF BIDDING DOCUMENTS

Standard Bidding Documents and further information about the projects are available for collection from the Office of the Procurement Officer between the working hours of 08:00am and 04:00pm everyday at the Federal College of Agriculture, Akure.

(6.0) SUBMISSION OF BIDS

(i) Interested Contractors and suppliers shall submit one copy of their Technical bid and completed financial bid. The Technical Bid and Financial Bid per Lot shall be placed in two different sealed envelopes and each appropriately labelled "Technical Bid' and "Financial Bid" as well as the "Project Name/Title" and "Lot No" on the same side of the envelope. The reverse side of each of these two envelopes containing separately Technical and Financial Bids should be enclosed in a third outer envelope which should be sealed and labelled Technical and Financial Bid" with the "Project Name/Title" and "Lot No" clearly written on the top Right Hand corner.

(ii) The outer envelope should be addressed to and submitted at

The reverse side of the outer envelope should also bear the "Bidder's Name, Address and Telephone Numbers",

(iv) Closing time for the submission of all bids (Technical and Financial) is supposed to be 12 Noon, Sunday 19thAugust, 2018. However, since Sunday is not a working day, submission of bids will close **on Monday 20th August 2018**.

(v) Late submission will not be entertained, no matter the circumstance please.

(7.0) OPENING OF BIDS

(i) Opening of Technical bids for the Supply of Goods and Works will commence at **12 Noon on Monday 20th August, 2018** in the International Conference Centre, Federal College of Agriculture, Akure. In view of the reason given in item 6 (iv) above.

(ii) Financial bids of those who are successful in the technical bid evaluation will be opened at a date to be communicated to them.

All bidding companies and/or their representatives, relevant professional bodies, Non-Governmental Organisations (NGOs), representatives of BPP and interested members of the public are hereby invited to witness the opening of the technical bids on the dates and times mentioned above.

(8.0) BIDS EVALUATION AND AWARD

(a) Immediately after the opening of the technical bids, all submissions will be assessed for eligibility using the non-scoring responsive criteria listed out above. Eligible submissions will then be assessed for capability based on the scoring of responsive criteria also listed above.

(b) Award of contract will be recommended in favour of the lowest evaluated responsive bids

(i) Only technically qualified Bidders shall be invited to the next stage of the procurement process.

(ii) Original documents of the Eligibility criteria of any Bidder may be requested for sighting.
