(5) The bidding document with technical specifications in English Language may be purchased by interested eligible Tenderers upon the submission of a written application: the bid document will be collected by the bidder or their representative from the purchaser’s address indicated below.

(6) Bids must be delivered to the address below **on or before 12:00 noon on the 19/02/2019** which is bid opening date: Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend at the address stated below.

(7) Bid price must have a minimum validity period of 90 days within which prices quoted cannot be changed. Any bid that offers bid validity period less than 90 days will be rejected

(8) Tenderer must show evidence of performance of similar nature of contracts in the past 3year(s).

(9) The Tenderer must show evidence of audited account of the company for the past three years by qualified Auditor(s).

(10) A Tenderer who are subject to any bankruptcy proceedings or who have been declared bankrupt and or have made any compromises with their creditors within two calendar years prior to the initiation of the procurement proceeding is not qualified to participate in the bidding process.

(11) If the Tenderer has been blacklisted/debarred from participating in public procurement activity is not eligible to participate in the bidding process.

(12) Bid must be signed by a verifiable Tenderer's authorized representative through evidence of Power of Attorney.

(13) The purchaser has the power to correct any arithmetical error dictated and adjust the bid price accordingly. Any bidder who does not accept such correction, its bid shall be rejected.

(14) Good(s) to be supplied must be accompanied by invoices stipulating the name of the product, quantity and price.

(15) All interested Tenderers must show evidence of their registration with Corporate Affairs Commission, Tax clearance certificate or Audited account reports for at least 3 years, evidence of experience in jobs of similar nature, evidence of registration with Benue State Tender's Board

(16) The purchaser has the right to reject all the bids without any liability.

(17) Contract to be awarded from the bidding process shall be fixed contract price.
