### **INVITATION TO BID FOR PROPOSED REHABILITATION OF COLLEGE OF NURSING AND MIDWIFERY, KADUNA**

### **PAMBEGUA CAMPUS, KUBAU LOCAL GOVERNMENT AREA, KADUNA STATE**

#### **(1.0) INTRODUCTION/BACKGROUND**

(1.1) In line Law No. 34 of 2018 establishing the Kaduna State College of Nursing and Midwifery, the requirements of the Nursing and Midwifery Council of Nigeria and the Kaduna State Government's policy of delivering good and qualitative healthcare services, there is need to upgrade facilities at the Pambegua Campus of the College to meet the minimum training standards. This will help enhance service delivery to the teeming populace of the State. The State Government, therefore, wishes to invite Contractors to tender for the rehabilitation of facilities at the Pambegua Campus.

(1.2) In compliance with the provisions of the Kaduna State Public Procurement Law 2016, The Ministry of Health, on behalf of the Kaduna State Government, hereby invites interested, eligible and competent Contractors to bid for Proposed Rehabilitation of College of Nursing and Midwifery, Pambegua Campus, Kubau Local Government Area, Kaduna State.

#### **(2.0) SCOPE/DESCRIPTION OF PROJECT**

Lot 1                      Rehabilitation of Existing Administrative Block, Tutorial Halls, Library, Lecture Hall, Staff Room and Generator House.

Lot 2	Construction of a 300-Capacity Auditorium.
Lot 3	Construction of Laboratory Complex (4nos. Labs).
Lot 4	Rehabilitation of Male Hostel (Block A, B & C), Female Hostel (3nos. Blocks), OPD and Sickbay
Lot 5	Rehabilitation of Female Hostel (Block A & B), 1no. Block of 6nos. Toilets, 1no. Block of 8nos. Toilets, 1no. Block of 6 cell Toilets and Bathroom Single Toilet (4nos.), and Construction of Fence for Existing Female Hostel).
Lot 6	Renovation of 2 Bedrooms (3nos. Blocks), Renovation of Staff Quarters with Extension, Rehabilitation of Existing Staff Quarters (3nos. Blocks) and Rehabilitation of Existing Staff Quarters (1no. Block).
Lot 7	External Works (Electrical and Mechanical Services).

### **(3.0) PRE-QUALIFICATION REQUIREMENTS**

#### **(3.1) Technical Bids**

Interested reputable contractors should submit but not limited to the following:

- (a) Certificate of registration/incorporation with the Corporate Affairs Commission (CAC)

- (b) Evidence of current registration with The Kaduna State Public Procurement Authority.
- (c) Company Audited Account for three years (2017, 2018 and 2019)
- (d) Evidence of current Tax Clearance Certificates for three years (2016, 2017 and 2018)
- ( e) Evidence of current registration of Business premises with the Kaduna State Ministry of Business Innovation and Technology.
- (f) Technical experience and qualifications of key personnel with evidence of registration with appropriate professional bodies.
- (g) Evidence of similar verifiable projects successfully executed/completed/on-going with attached copies of award letters, payment and completion certificates.
- (h) Equipment and Technology capacity with evidence of ownership/lease agreement.
- (i) Evidence of Financial Capability and Banking Support.
- (j) Evidence of VAT registration and remittances.
- (k) Evidence of compliance with Industrial Training Fund (ITF).
- (l) Evidence of compliance with PENCOM.
- (m) Evidence of Bid Security (if applicable) in the form of Bank Guarantee or Certified Bank Draft from a reputable Bank in Nigeria.
- (n) Any other information that would be relevant.

(3.2) The documents shall be arranged in the order above, paginated and signed on each page by an authorized representative of the Bidder.

(3.3) Collection of Financial Tender Documents

Interested companies/firms can obtain the Tender Documents, from 17th March, 2020 between the hours 10.00AM – 4.00PM, Mondays to Fridays at a non-refundable tender fee of:

(3.4) Any submission not accompanied with the draft will Not be considered;

(3.5) The draft must Not be in the Financial Bid Envelope.

**(4.0) SUBMISSION OF BID DOCUMENTS**

(a) Completed Technical and Financial bids are to be submitted in three (3) hard copies each (Original, Duplicate and Control copies).

(b) The Technical and Financial bids must be inserted in separate sealed envelopes clearly marked “Technical Bid” and “Financial Bid.”

(c) All the envelopes must bear the name and contact number of Bidder at the rear sides with the ‘Project Description’ and ‘Lot No.’ clearly marked at the top left-hand corner of the envelopes and addressed to:

(d) The Original and Duplicate copies of the Technical and Financial bids shall be placed in a large outer envelope which shall be dropped into the Bid Box.

(e) The Control copies of the Technical and Financial Bid documents shall be marked at the top right-hand side as ‘Control Copy’, and dropped in the Control Box.

(f) Failure to comply with this requirement of separate and sealed envelopes for Technical and Financial Documents shall lead to disqualification.

(g) The submission shall be made not later than **12.00PM, 16 April, 2020**.

#### **(5.0) OPENING OF BIDS**

(5.1) The Technical and Financial Bid documents received shall be opened immediately after the close of receipt of bids on **16 April 2020** in the presence of the representatives of the Bidders at:

(5.2) Only technically qualified bids will proceed to the financial evaluation stage
