(3) ELIG	BILITY REQUIREMENTS:		

Prospective Contractors shall be required to submit the following pre-qualification documents:

(i) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Forms CAC2 and CAC7;

- (ii) Evidence of Company's Income Tax Clearance Certificate for the last three (3) years valid till 31st December, 2020;
- (iii) Evidence of current Pension Compliance Certificate valid till 31st December, 2020;
- (iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2020;
- (v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2020;

(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31/06/2020 or valid Certificate issued by BPP;

(vii) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Chukwuemeka Odumegwu Ojukwu University or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

(viii) Company's Audited Accounts for the last three (3) years 2017, 2018, 2019;

(ix) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;

(x) Company profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications;

(xi) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

(xii) For supply of Equipment Letter of Authorisation from Original Equipment Manufacturers

(xiii) All documents for submission must be transmitted with a Covering/ Forwarding Letter under the Company/Firm's Letterhead Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and email address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.

(4) COLLECTION OF TENDER REQUIREMENTS:

Prospective Contractors shall be required to collect tender documents in the office of the Director, Physical Planning Unit, between the hours of 10:00am to 4:00pm daily. A non-refundable Tender fee of N10,000.00 per Lot shall be paid into Chukwuemeka Odumegwu Ojukwu University's Multipurpose Account Number 4110009552 Fidelity Bank. The payment shall be converted into a receipted evidence of payment from the Revenue Unit of the University Bursary.

(5) SUBMISSION OF TENDER DOCUMENTS:

Please ensure that you sign the Bid Submission Register as the University will not be held liable for misplaced or wrongly submitted bids. (7) NOTES:

- (i) Bids must be in English Language and signed by an official authorised by the bidder;
- (ii) Bids submitted after the deadline for submission would be returned unopened;
- (iii) Bidders should not bid for more than two (2) Lots;
- (iv) All costs will be borne by the bidders;

(v) Only the pre-qualified bidders at technical evaluation will be contacted at a later date for financial bids opening, while the financial bids of un-successful bidders will be returned un-opened;
