**INVITATION TO TENDER**

(1) Tenders are invited from suitably qualified contractors registered with the Delta State Oil Producing Areas Development Commission (DESOPADEC) for the execution of Projects (BATCH A) in various oil producing communities listed in section 4 below:

(2) Tender application forms and documents are to be collected from the Tenders Board Secretariat, Department of Planning, Research and Statistics (PRS) of the Commission at Esi Road Office, Warri, and to return same **not later than 3<sup>rd</sup> APRIL, 2017 - (Twenty-One (21) days from the date of this Publication)** accompanied with the following:

(i) Evidence of Registration with the Corporate Affairs Commission including Memorandum/Article of Association/Form 1;

(ii) Evidence of Registration with the Delta State Oil Producing Areas Development Commission;

(iii) Valid Tax Clearance Certificate for the past Three (3) years;

(iv) Evidence of previous jobs successfully executed;

(v) Evidence of DSIR Card

(vi) Verifiable contact address of Business Office(s) /Premises and current utility Bills;

(vii) Evidence of payment of appropriate Tender and Processing fees for the project;

(viii) Company profile showing organizational structure and resume of relevant key professional staff (including their professional and technical qualifications) that will carry out the project;

(ix) A verifiable evidence of VAT registration;

(x) Documented evidence of financial capability of the company;

(xi) Telephone numbers, e-mail address of the company plus details of contact person(s)

Tenderers are expected to fully comply with the above requirements as failure to do so may result in the rejection of Tenderers' bid. Submission of fake or fraudulently obtained documents will result in immediate disqualification of Tenderer.
