**(B) Application Requirements**

- (2) Brief history of the company stating nature of work undertaking.
- (3) Evidence of incorporation by Corporate Affairs Commission.
- (4) Tax clearance certificate for the last three years. (2014, 2015, 2016).
- (5) Current VAT Certificate.
- (6) Evidence of similar jobs successfully completed in the last three years.
- (7) List of equipment to be used for the project and their location (where applicable).
- (8) List of key personnel/officers to be attached to the project and their qualification. Enclose photocopies of professional certificates as well as evidence that non of the company's directors has been convicted for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation, falsification of facts relating to any matter.

- (9) Evidence of financial capability. A Bank's reference indicating readiness to finance the project if the applicant's bid is successful as well as audited account for the last three (3) years.
- (10) An affidavit disclosing whether or not any officer of this college's relevant committee on procurement is a former or present Director, Shareholder or has any pecuniary interest in the applicant Company.
- (11) Evidence of compliance with the Pension Reform Act 2004.
- (12) Evidence of compliance with the Industrial Training Fund Act.
- (13) Evidence of submission of annual returns to the Corporate Affairs Commission.
- (14) Audited Accounts report for three (3) years (2014, 2015, 2016).

**(C) SUBMISSION OF APPLICATION**
