REQUIREMENTS FOR TENDER

Interested contractors must submit along with their tenders the following documents.

- (a) Evidence of registration with EKITI SUBEB

- (b) Evidence of registration of company with Corporate Affairs Commission

- (c) Evidence of company registration with Federal Inland Revenue Services (FIRS)
- (d) Evidence of registration with Bureau for Public Procurement.
- (e) Three Years Tax Clearance 2017, 2018 and 2019
- (f) Evidence of Payment of 3 years Development Levies: 2017, 2018 and 2019
- (g) Evidence of previous works/projects satisfactorily executed and
- (h) Evidence of qualified technical and professional staff.

Each would be bidders is expected to pay a non-refundable tender fee of:-

- (i) N40,000.00 for construction of classrooms
- (j) N20,000.00 for renovation, VIP Toilet and fencing works
- (k) N10,000.00 furniture

(4) Tender documents and additional information are to be collected from the office of the Director, Planning Research and statistics, interested contractors may tender for more than one Lot or Lots Separately and should note that Failure to include any of the requirements above renders the application invalid.
