## (1.0) INTRODUCTION

The National Primary Health Care Development Agency (NPHCDA) is a Federal Government Agency under the Federal Ministry of Health responsible for development and strengthening of primary health care services nationwide.

The Agency in keeping with the Health Agenda for Change of the present administration is accelerating the implementation of Universal Health Coverage (UHC) through Primary Heath Care (PHC) Programme. In compliance with the Public Procurement Act 2007 as regards procurement of goods, works and services, NPHCDA invites interested and qualified bidders for the procurement of the following under listed Projects in 2020 Appropriation.

### (3) ELIGIBILITY REQUIREMENTS:

Interested and competent Contractors. Suppliers and Service Providers/Consultants wishing to carry out any of the Projects listed above are required to submit the following documents which will be subjected to verification and due diligence by the Agency:

- (A) Mandatory/Responsive Requirements: Failure to fulfil any of the under-listed requirements will render a bid, disqualified:
- (i) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including forms C02 and C07 (Form 1.1);
- (ii) Evidence of current Tax Clearance Certificate for the last Three (3) years expiring 31st December 2020; with minimum average turnover of 15 million for Works/2 million for Goods over last 3 years;
- (iii) Unabridged Company's Audited Accounts for the immediate past Three (3) years, 2017, 2018, 2019 duly signed and stamped by a professional Audit Firm;
- (iv) Evidence of current Pension Compliance Certificate valid till 31st December 2020;
- (v) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2020;

- (vi) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December 2020;
- (vii) Evidence of valid registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30th June, 2020 or valid Certificate issued by Bureau of Public Procurement (BPP);
- (viii) Evidence of financial capability to execute the project by submission of Reference Letter from reputable commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed.
- (ix) List of Plants/Equipment with Proof (Receipt) of Ownership/Lease for Construction, Borehole & Renovation Works;
- (x) Evidence of current premise's Registration with Pharmacists Council of Nigeria for Supply of Vaccines, Drugs and Syringes
- (xi) Evidence of product Registration with NAFDAC for Supply of Syringes and Vaccines;
- (xii) Evidence of product WHO Prequalification and PQS number for Supply of Vaccines, Syringes & Safety Boxes;
- (xiii) Letter of Authorisation from the Original Equipment Manufacturers listed in the Approved Policy for Procurement of Health and Medical Equipment for Tertiary Hospitals in Nigeria, for bidders of Lot 7;
- (xiv) Bid Bond/Tender Security for Supply of Vaccine & Syringes only;
- (xv) Only companies included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorised representatives should bid for vehicles
- (xvi) A sworn affidavit:

that none of the Directors has been convicted in any Country for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter; and

disclosing whether or not any officer of relevant committees of the National Primary Health Care Development Agency or Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars.

(xvii) Detailed Company's profile with Curriculum Vitae of key Officers/Professional Personnel including photocopies of relevant Professional/Technical Certificates/Qualifications: at least 3 COREN (1 Civil, 1 Mechanical & 1 Electrical), 1 QSRBN, 1 ARCON, 1 CORBON (for Works);

(xviii) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Award, Valuation Certificates, Job Completion Certificates and photographs of the projects. Only jobs that are similar in nature (i.e type of goods supplied, nature of the works or services carried out) shall be considered.

(xix) All documents for submission must be transmitted with a COVERING/FORWARDING letter under the Company/Firm's Letter Head paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, GSM Number, and e-mail address. The Letter Head Paper must bear the Name and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

Payee full name should be the Name of Company, not individual's name.

Bring the print out together with the copies of the Bank Teller with stamp of the Bank on it to the Central Pay Office (CPO) of the Agency's Headquarter at Plot 681/682 Port-Harcourt Crescent, Off Gimbiya Street, Area 11 Garki, Abuja to collect receipt which would be used to obtain bid document at Procurement Unit. Firms interested in Lots 22 & 23 will not pay at this stage until after shortlisting.

## (6) SUBMISSION OF BID DOCUMENTS

Prospective companies are to submit bid for each of the Lot desired, the completed Technical and Financial bids, packaged separately in sealed envelopes and clearly marked as "Technical Bid" and "Financial Bid". Thereafter, put the two sealed envelopes together in a bigger sealed envelope marked with the Appropriate Project Title and relevant Lot Number, Name of company, address, and valid contact phone number behind. All the envelopes must carry the name and phone number of the contractor for ease of identification. #### IMPORTANT INFORMATION

- (1) No company should bid for more than two (2) Lots;
- (2) The standard Bidding Document purchased must be filled and submitted with the company profile. Any criteria stated in the Standard Bidding Document will be considered as part of prequalification criteria. Note that the standard bidding document is according to BPP guidelines;
- (3) The documents should be arranged in the order listed at 3 above and clearly separated by dividers;
- (4) The standard means of communication between the Procurement Unit and all bidders shall be through emails, all bidders are therefore advised to ensure that current email address accompany their bids;
- (5) Companies with poor record of performance at NPHCDA need not apply;
- (6) All CAC, TAX Certificates and PENCOM may be referred to Corporate Affairs Commission, Federal Inland Revenue Service (FIRS), National Pension Commission, Security Agencies and other relevant bodies for **VERIFICATION**;
- (7) NPHCDA is not bound to pre-qualify any bidder and reserves the right to annul the Procurement process at any time without incurring any liability in accordance with Section 28 of the Public Procurement Act 2007;
- (8) Any bidder who fails to comply with the above stated instructions and instructions in the Standard Bidding Documents will automatically be disqualified;
- (9) Goods & Works: Only pre-qualified bidders at the technical evaluation will be contacted at a later date for financial bids opening, while financial bids of un-successful bidders will be returned un-opened;
- (10) Lot 22 & 23: Only shortlisted consultants will be invited at a later date for collection of Request for Proposals;
