- (h) Evidence of Audited Accounts for at least three (3) years (2017,2018,2019)
- (i) Evidence of financial capability to execute the project by submission of reference letter form a reputable commercial bank in Nigeria including willingness to provide to provide credit facilities for the execution of the project when needed.
- (j) Verifiable documentary evidence of at least 3 similar jobs, executed within the last (5) five years including letter of award, certificate of completion and photographs of the project.
- (I) Evidence of construction equipments with proof of ownership or relevant lease agreement.
