(g) Evidence of Sworn Affidavit disclosing whether or not any Officer of the relevant committees of the Federal University of Agriculture, Abeokuta or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.

(h) Company's audited account for the last three (3) years (2015, 2016 and 2017) duly stamped by a certified Auditor to demonstrate the financial capability of the bidder in terms of Profitability and adequate Working Capital with an annual Turnover of not be less than N20 Million;

Evidence of financial capability of the bidder to execute the project including Reference
Letter from a reputable commercial bank indicating willingness to provide credit facility for
execution of the project when needed;

(j) Company Corporate Profile with Curriculum Vitae of key Staff to be deployed for the project, including copies of their Academic/Professional qualification i.e. COREN, QSRBN, ARCON, etc as applicable.

(k) Verifiable documentary evidence of at least three (3) similar jobs in Hospital Buildings/Library Books in the last five (5) years including Letters of Awards/LPO, Valuation Certificates/Payments and Photographs of the Projects;

(I) List of Plants/Equipment with proof of Ownership/Lease (Construction Works only);

(m) All documents for submission must be transmitted with a Covering Forwarding letter under the Company/Firm's Letter Head Paper bearing among others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (Preferably GSM No), and e-mail address. The Letter Head Paper must bear the Names and Nationality of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.
