(5) SUBMISSION OF TENDER DOCUMENTS

Prospective Bidders are to submit for each of the Lot desired two (2) hard copies each of the technical and financial bids with softcopy of financial bid only in MS Excel format, packaged separately in sealed envelopes and dearly marked as Technical Bids" or "Financial Bid". Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to The Rector, Niger State Polytechnic, P. M.B. 01, Zungeru, Niger State and clearly marked with the name of the project and lot number. Furthermore, the reverse of each sealed envelope should bear the name and address of the Bidder and drop in the designated Tender Box in Office of the Registrar, Niger State Polytechnic, Zungeru not later than **12:00 Noon on Monday, 24 February, 2020**.
