Accordingly, the college wishes to invite reputable contractors with relevant, proven competence and experience to submit tenders for the execution of the following projects:

(3.0) ELIGIBILITY REQUIREMENTS

Prospective Bidders must possess the under-listed requirements:

- (i) Evidence of Certificate of Incorporation with Corporate Affairs Commission (CAC) including Forms CAC2 and CAC7

- (ii) Evidence of Company's Current Tax Clearance Certificate for the last three years (2015, 2016 and 2017) valid till 31 Dec, 2018 with a minimum average annual turnover of Twenty Million Naira (N20,000,000.00);

- (iii) Evidence of Current PENCOM Compliance Certificate valid till 31 Dec, 2018;
- (iv) Evidence of Current Industrial Training Fund (ITF) Certificate valid till 31 Dec, 2018;
- (v) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till Dec, 2018;
- (vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Suppliers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or a valid Certificate issued by BPP;
- (vii) Current sworn Affidavit:
 - (a) disclosing whether or not any officer of the relevant Committees of Federal Government College, Warri or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and confirm that all information presented in its bid are true and correct in all particulars;
 - (b) The company is not in receivership, insolvent or bankrupt, and
 - (c) The company has any Director who has ever been convicted in any court in Nigeria or any other country for criminal offences in relation to fraud or financial impropriety,
- (viii) Evidence of Financial Capability to execute the job, by submission of Reference Letter from a reputable Commercial Bank with willingness to provide credit facility for the execution of the project when needed;
- (ix) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (ARCON, COREN, QSRBN, CORBON, etc);

(x) Verifiable documentary evidence of, at least, (3) similar job(s) successfully Executed in the last Five (5) years including Letters of Awards, Valuation Certificates and/or Job Completion Certificates and Photographs of the projects;

(xi) List of Plants and Equipment with proof of ownership or lease agreement;

(xii) All documents for submission must be transmitted with a covering/forwarding letter under the Company/Firm's Letter Head paper bearing amongst others, the Registration Number (RC), as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone number(s) (preferably GSM No.) and valid e-mail address and official Company's address. The Letter Head paper must bear the Names, Nationalities and Telephone Numbers of Directors of the company at the bottom of the page duly signed by the authorised officer of the firm.

(4.0) COLLECTION OF BID DOCUMENTS

Interested and competent bidders are requested to collect Standard Bidding Document (SBD) from the address below on presentation of evidence of payment of a non- refundable tender fee of N10,000.00 per Lot paid into FGC, Warri's Remita account in any reputable commercial bank in Nigeria.

(5.0) SUBMISSION OF TENDER DOCUMENT

Prospective bidders are to submit two (2) hard copies each of the Technical and Financial bids only in MS Excel format for desired lot in Two (2) separate envelopes, clearly marked "Technical Bid" or "Financial Bid". The Two envelopes should be enclosed in one larger envelope labelled with the project name at the 'top right hand corner' and the company's name behind and addressed to:

The document should be deposited In the Tenders Box at the Office of the Principal, FGC, Warri, **not later than 12.00 noon on Monday 11 March, 2019.**

(6.0) OPENING OF BIDS

The Technical bids shall be opened immediately after the deadline for submission **at 12.00 noon on Monday 11 March, 2019** in the College Assembly Hall. Company representatives and interested members of the public, including relevant professional organisations are hereby invited to witness the opening of Technical bids.

(7.0) GENERAL INFORMATION

- (i) Certificates may be referred to the respective issuing Authorities for verification and authentication,
- (ii) Contractors are not permitted to bid for more than One (1) lot. Any bidder that violates this rule shall be disqualified, and only successful bidders will be invited for the next stage of the bidding process,
- (iii) Only Pre-qualified bidders at Technical Evaluation will be invited at a later date for the Financial Bid Opening, while bids of unsuccessful contractors will be returned un-opened,
- (iv) Technical and Financial Bids enclosed in one and same single envelope that will expose the Technical and Financial Bids at the time of opening shall be disqualified,
- (v) Submission that does not meet up with the requirements specified above shall be rejected,
- (vi) The evaluation shall be strictly based on the requirements specified above,
- (vii) This advertisement is published for information purpose only, and should not be construed as a commitment or obligation on the part of FGC, Warri to award these contracts,
