INVITATION TO TENDER FOR COVID-19 EMERGENCY PROCUREMENT FEDERAL MEDICAL CENTRE ABEOKUTA

(1.0) INTRODUCTION

In compliance with the requirement of the Public Procurement Act 2007 and extent regulations on the Procurement of Goods, Works and Services, the Federal Medical Centre Idi-Aba, Abeokuta in furtherance of its responsibility as a tertiary health institution in the management of Covid-19 Pandemic, hereby invites interested, competent and reputable contractors with relevant experience, requisite expertise and good track record to submit Technical and Financial Bid for the underlisted project:

(2.0) ELIGIBILITY REQUIREMENTS

For Financial Bid to be considered, prospective bidders must be technically qualified by demonstrating qualification in the following areas:

- (i) Valid certificate of incorporation issued by Corporate Affairs Commission (CAC) including forms CAC 2 and CAC 7.

- (ii) Evidence of Tax Clearance Certificate for the last three (3) years (2017, 2018, 2019) valid till 31st December 2020 with minimum average annual turnover of N10 million;
- (iii) Verifiable evidence of Pension Compliance Certificate valid till 31st December, 2020.
- (iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2020.
- (v) Verifiable evidence of registration on the Bureau of Public Procurement (BPP) National Database of contractors, Consultants and Service Providers in form of current Interim Registration Report (IRR) expiring on 30th June, 2020 or valid certificate issued by Bureau of Public Procurement (BPP).
- (vi) Verifiable evidence of Nigeria Social Insurance Trust Fund (NSITF) valid till 31st December, 2020.
- (vii) A Sworn Affidavit:
 - disclosing whether or not any officer of the relevant committees of the Federal Medical Centre, Abeokuta or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
 - that neither the company nor its directors is undergoing any form of receivership, insolvency or bankruptcy
- (viii) Company's Audited Account for the last three (3) successful years (2017, 2018, 2019) duly stamped by a reputable Audit Firm
- (ix) Verifiable evidence of at least three (3) similar jobs executed in the last five (5) years supported with letters of award and commissioning, activity description, client location, value of job, status of the projects, practical completion certificate etc.
- (x) Verifiable evidence of financial capability of the company from a reputable Commercial Bank indicating willingness to provide credit facilities for the execution of the project.
- (xi) Letter of Authorization from the Original Equipment Manufacturers listed in the Approved Policy for Procurement of Health and Medical Equipment for Tertiary Hospitals in Nigeria.

(xii) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner);

(xiii) All documents for submission must be transmitted with a covering/forwarding letter under the company/firm's letter Head paper bearing amongst others: the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferable GSM No) and e-mail address. The letter head paper must bear the Names and Nationalities of the Directors of the company at the bottom of the page duly signed by the authorized officer of the firm.

Failure to submit any of the listed documents shall be sufficient grounds for disqualification.

Abeokuta between the hours of 8.00am and 4.00pm daily (Monday – Friday) on or before **12:00 noon of Thursday 19th November, 2020**.

Technical Bid shall be opened immediately after the close of submission at **12:00 noon of Thursday 19th November, 2020**, at the Board Room of Federal Medical Centre, Idi-Aba, Abeokuta.
