PREAMBLE

Lagos State Polytechnic has secured the approval of the State Government to utilize its Year 2020 Capital Budget for the Construction of Administrative Building on a 2-Lot arrangement:

Lot 1	SCOPE OF WORK: This comprises Construction of the Polytechnic Administrative Building consisting of building framework up to finishing on three floor level and the associated external works which include hard and soft landscaping on Ikorodu Campus.
Lot 2	Mechanical/Electrical Services Installation and Painting for the Polytechnic Administrative Building with Package No. No. ISP/W/NCB/006B/20

SCOPE OF WORK: This consists of Mechanical/Electrical Services Installation and Painting respect of the proposed Polytechnic Administrative Building on Ikorodu Campus

Bidding will be conducted through National Competitive Building (NCB) procedures as specified in the Lagos State Public Procurement Guidelines for Works and are open to all bidders from eligible contractors as defined in the guidelines.

The Lagos State Polytechnic invites eligible contractors to submit sealed bid documents for the above projects detailed in the bidding document.

QUALIFICATION REQUIREMENTS/ELIGIBILITY CRITERIA

Interested and competent contractors wishing to carry out the project as described

above will be required to submit the following documents:

- (1) Copy of the Company's Certificate of incorporation with Corporate Affairs Commission.
- (2) Copy of current Certificate of Registration with the Lagos State Government as Works Contractor.
- (3) Copy of Evidence of Registration with Lagos State Polytechnic
- (4) Evidence of payment of VAT with TIN Number and evidence of VAT remittances to the last 3 years.
- (5) Copy of Company Tax Clearance Certificate for the last 3 years (2016, 2017, 2018).
- (6) Evidence of 3 years Development Levy for two (2) Directors.
- (7) Company's Audited Account for the last three (3) years.

- (8) Possession of experience as a prime contractor in at least two (2) projects of similar job completion within the last five (5) years.
- (9) Evidence of Financial capability (Reference Letter from reputable bank).
- (10) Copy of the Company's profile with relevant information, showing registration of technical/managerial staff with relevant professional/regulatory bodies.

Contractors are to collect Financial bid Documents from Procurement Office, Lagos State Polytechnic, Ikorodu upon payment of non-refundable Tender Fees of Ten Thousand Naira (N10,000.00) only per Lot to LASPOTECH School Income Account 2019175726, First Bank Nigeria Plc. and attach evidence of payment.
