- (i) Evidence of financial capability to execute the project including Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of foe project when needed;

Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to the Principal, Federal Government College, Enugu, Enugu State and clearly marked with (the name of the prefect and

the Lot number). Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and drop in the designated Tender Box at the Principal's Office, FGC, Enugu **not later than 12:00 noon on Monday. 26 November, 2018.**

The technical bids will be opened immediately after the deadline for submission by 12:00 noon on Monday 26 November, 2018 in the College Multipurpose Hall In the presence of bidders or their representatives, while the financial bids will be kept un-opened.
