- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till December 2018.
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service providers by submission of Interim Registration Report (IRR) expiring on 03/01/2019 or valid certificate Issued by the Bureau of Public Procurement (BPP).
- (g) Sworn affidavit disclosing whether or not any officer of the relevant committees of Federal Government College Kwali or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in the bid are true and correct in all particulars.
- (h) Company's Audited account for the last three (3) years, (2015, 2016 and 2017)
- (i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank including willingness to provide credit facility for the execution of the project when needed.
- (j) Company Profile with the Curriculum Vitae of key staff to be deployed for the project including copies of them Academic/Professional qualifications, (in case of construction COREN, QSRBN, ARCON and CORBON) for works;
