Prospective bidders are to submit bid for desired Lot, two (2) hard copies each of the technical and financial bids with soft copy of financial bid only in MS Excel format, packaged separately in two sealed envelopes and clearly marked as "Technical Bid" and "Financial Bid". Thereafter, put the two sealed envelopes together in a bigger sealed envelope addressed to the Principal, Federal Government Girls College, Sagamu, Ogun State and clearly mark with (the name of the project and the Lot number). Furthermore, the reverse of each sealed envelope should have the name and address of the bidder and drop in the designated Tender Box at the Principal's Office, FGGC, Sagamu **not later than 12 noon on Wednesday, 19 September, 2018.** 

#### (6.) OPENING OF BID

The technical bids will be opened immediately after the deadline for submission at 12.00 noon on Wednesday, 19 September, 2018 at the PTA HALL of the college. Bidders/Company representatives and interested members of the public including relevant professional bodies, civil society and Non-Governmental organizations are hereby invited to witness the opening of the technical bids.

#### (7.) GENERAL INFORMATION

- (a.) Bids must be in English Language and signed by an official authorized by the bidder;
- (b.) Bids submitted after the deadline for submission would be returned un-opened; Bidders should not bid for more than one (1) Lot;
- (c.) All costs will be borne by the bidders;
- (d.) All pre-qualified bidders will be contacted for financial bid opening at a later date while financial bids of unsuccessful bidders will be returned un-opened;
- (e.) Any Bidder who fails to comply with any of the eligibility requirements as stated will be disqualified;
