(1) INTRODUCTION

The Federal Government of Nigeria has allocated funds to the Federal Science and Technical College Kuta-Shiroro in the 2018 Appropriation for the execution of Policies, Programmes and Projects towards achieving the mandate of the College. Accordingly, the College wishes to invite reputable contractors with relevant proven competence and experience to submit tenders for the execution of the following projects:

(1) ELIGIBILITY REQUIREMENTS:

Prospective Bidders must possess the underlisted requirements to be eligible in this procurement:

(i) Evidence of Certificate Incorporation with the Corporate Affairs Commission (CAC) including Forms CAC2 and CAC7;

(ii) Evidence of Company's current Tax clearance Certificate for the last three (3)years-2015,2016 and 2017,Expiring on 31st December,2018

- (iii) Evidence of current Pension Compliance Certificate valid till 31st December, 2018;
- (iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2018;
- (v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31stDecember, 2018;
- (vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP.

(vii) Sworn Affidavit:

Disclosing whether or not any officer of the relevant Committees of the Federal Science and Technical College, Kuta-Shiroro, Niger State or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

- That the company is Not in receivership, insolvent or bankrupt,
- That the company does not have any Director who has ever been convicted in any court in Nigeria or any other country for criminal offence in relation to fraud or financial impropriety;

(viii) Company's Audited Accounts for the last three years (2015, 2016 and 2017), duly signed and stamped by ICAN/ANAN professional(s);

(ix) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications: COREN, QSRBN, ARCON, CORBON;

(x) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(xi) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

(xii) List of Plants/Equipment with proof of Ownership/Lease (where applicable);

(xiii) All documents for submission must be transmitted with a covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(2) SUBMISSION OF BID DOCUMENTS

Interested and competent bidders are requested to collect bid documents from the address below, upon presentation of evidence of payment of non-refundable tender fee of N 10,000.00. Completed Technical and Financial bids should be packaged in separate sealed envelopes (two sets of hard copies) and the two envelopes should be enclosed in a large envelope labelled "Technical and Financial Bids" with the Project Name at the top right corner with company name behind and addressed to:

(3) OPENING OF BIDS

The technical bids will be opened immediately after the deadline for submission at 12:00 noon on **Monday 20 August, 2018** at the Conference Hall of the College. Bidders/Company representatives and interested members of the public including relevant professional bodies, Civil Society and Non-Governmental Organisations are hereby invited to witness the opening of the technical bids.

(4) PLEASE NOTE THAT:

- (i) Any bid received after the deadline for submission shall be returned un-opened.
- (ii) Certificate may be referred to the respective issuing authority for verification and authentication;
- (iii) Contractors are not permitted to bid for more than one lot. Any bidder that violates this rule shall be disqualified and only successful bidders will be invited at a later date for the next stage of the bidding process,
- (iv) Technical and Financial bids enclosed in one and same single envelope that will expose the Technical and Financial bids at the same time of

opening shall be disqualified;

(v) Submission that does not meet up with the requirement specified above shall be rejected;

(vi) The evaluation shall be strictly based on the requirement specified above;

(vii) This advertisement is published for information purpose, and will not be construed as a commitment or obligation on the part of FSTC Kuta-Shiroro to award these contracts;
