- (j) Sworn affidavit disclosing whether or not any officer of the relevant committees of Federal University Dutse or the Bureau for Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the firm expressing interest and, to confirm that all information presented are true and correct in all particulars.
