(A) TECHNICAL AND FINANCIAL BIDS REQUIREMENTS

(v) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letter of Awards, Valuation Certificates and Job Completion Certificates;

(vi) A Sworn Affidavit disclosing whether or not any officer of Kaduna Polytechnic, Kaduna, or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

(vii) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2018 or valid Certificate issued by BPP;

(b) The tender document's fee has been reduced to N10,000 per Lot.

(c) The submission deadline has been extended by three (3) weeks from 7th December,
2017 to 2nd January, 2018 at 12 noon)

(d) The time of the technical bid opening will follow immediately after the closure.

(e) Bidders are expected to provide the following information along with their submission.

(i) The list of plants/equipment with proof of ownership/tease (where applicable).

(ii) The minimum turnover to be eligible for the project

(a) For Lots 1, 2 and 3 the minimum annual turnover of bidders should not be less than (N150 million Naira).

(b) For Lots 4 to 6 the minimum annual turnover should not be less than (N30 million Naira).

(iii) Collection of tender documents is at the Office of the Head of Procurement Division, Kaduna Polytechnic, Tudun Wada Kaduna from 8 am to 4 pm each day, Monday to Friday.

(iv) The technical and financial bids should be packed in separate sealed envelopes each marked "Technical bid" and "Financial bid" at the top left hand corner, and both packed in a larger sealed envelope.

(v) That only technical bid will be opened on the day of bid opening (2nd January, 2018 at 12 noon). The opening of financial bids will only be for those whose technical bids evaluation are successful and will take place two weeks after the opening of the Technical bids.

(f) No bidder should bid for more than two (2) Lots (among 1-3) or sub-lots (among 4-6).
