(1.0) INTRODUCTION

The Federal Polytechnic, Ile-Oluji invites interested, competent and reputable bidders to apply for Tender and submit the required information as well as comply with other pre-requisites of the Tender criteria as listed below for the following:

(2.0) SCOPE OF WORK

YEAR 2018 CAPITAL PROJECTS:

LOT 1: Construction Of Polytechnic Library at the permanent site

LOT 2: Construction of 500 –Seater ICT Complex at the Permanent Site

LOT 3: Procurement of Equipment/Tools for Workshops, Studios & Laboratory for Schools

(3.0) ELIGIBILITY CRITERIA

Interested Bidders are required to submit the under-listed minimum bidding requirements:

- (A) Evidence of Registration with Corporate Affairs Commission (CAC).
- (B) A comprehensive Company profile of Contractor to include verifiable staff list, certificates of Academic and Professional qualification of company staff.
- (C) Evidence of Tax Clearance Certificate for the three (3) years (2015-2017).
- (D) Company Audited Account for the last three (3) years (2015-2017) by a qualified Audit firm with official stamp.
- (E) Current Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of the Interim Registration Report (IRS).

- (F) Current certificate of compliance with Pensions Reform Act 2004.
- (G) Current certificate of compliance with industrial Training Fund (ITF) amendment Act 2011.
- (H) Evidence of financial capability/bank reference letter showing line of credit available to the tune of N2Gm for the project LOTS 1 and 2 And 10m for Lot3.
- (I) Evidence of ownership or access to lease of relevant construction equipment and the status (where applicable)
- (J) Evidence of experience in at least (3) jobs of similar nature or complexity executed within the last five (5) years with letters of contract awards and certificate of job completion, Interim Performance Certificate (at least 70% completion) for ongoing projects should be included.
- (K) The Letterhead of every bidder must bear the registration number as issued by CAC, contact address/e-mail at the top and the names and nationalities of the Directors of the company at the bottom of the page.

(L) A sworn affidavit in line with Section 16 Subsection 6(f) of the Public Procurement Act 2007 stating among other things:

That a documents/information presented in the bid are genuine and verifiable in all particulars,

Whether or not any current officers) of the Federal Polytechnic Ile-Oluji or The Bureau of Public Procurement (BPP) is a former or present Director, shareholder or has any pecuniary interest in the company.

(M) Letter of intent to Tender duly signed by the Chief Executive Officer or authorized person of the bidding firm

NOTE: All bids must be arranged in the order above (A-M), numbered and initialled by the authorized person.
