- Disclosing whether or not any officer of the relevant committees of the Federal Polytechnic Oko, or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder, and G. confirm that all information presented in its bid are true and a. correct in all particulars.
- That the company is not bankrupt, in receivership or under liquidation or involved in any litigation which can potentially affect the company's ability to effectively discharge their responsibility if engaged.
 - (b) No director of the Company has been convicted of any procurement fraud in any country;
 - (h) Company's Audited Account for the last three years- (2017, 2018, and 2019).
 - (i) Evidence of Financial capability to execute the project by submission of Reference Letter from a reputable c. commercial bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed.
 - (j) Company's Profile with the Curriculum Vitae of Key Staff to d. be deployed for the project, including copies of their Academic/Professional qualifications like COREN, e. QSRBN, ARCON, CORBON etc.
 - (k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of f. Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects.
 - (I) List of Plants/Equipment with proof of Ownership/Lease
 - (m) All Document for submission must be transmitted with a Covering/ Forwarding letter under the Company/firm's Letter Head Paper bearing amongst others, The Registration Number (RC) as issued by the corporate affairs commission (CAC), Contact address, Telephone Number (preferably GSM no.) and e-mail address, The Letter Head Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the pages, duly signed by the authorized of the firm.
