### (1.0) INTRODUCTION

(h) Letter of Authorisation from Original Equipment Manufacturers (OEMs);

(i) Evidence of registration/accreditation with Computer Professionals Registration Council of Nigeria and National Information Technology Development Agency (NITDA);

(j) Company's Audited Accounts for the last three (3) years – 2017, 2018, 2019;

(k) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank in Nigeria; indicating willingness to proof credit facility for the execution of the project when needed;

(I) Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications;

(m) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;
