- (3) Evidence of registration with NSUBEB;
- (4) Evidence of Company Income's Tax Clearance Certificates for 2017, 2018 and 2019 valid till 31st December, 2020;
- (5) Evidence of current Pension Compliance Certificate valid till 31st December 2020;
- (6) Evidence of current National Social Insurance Trust Fund (NSITF) Compliance Certificates valid till 31st December 2020;
- (7) Evidence of current Industrial Trust Fund (ITF) Compliance Certificate valid till 31st December 2020;
- (8) Company's Audited Accounts for years 2017, 2018 and 2019 properly stamped and endorsed by a reputable Audit Firm;
- (9) Evidence of Financial capability to execute the projects including Reference letter from a reputable bank address to the Executive Chairman, Niger SUBEB;
- (10) Verifiable documentary evidence of similar jobs successfully executed including Award Letters and Completion Certificate);

- (i) Disclosing whether or not any officer of the relevant Committees of Niger State Universal Basic Education Board or the Niger State Public Procurement Board is a former or present Director, shareholder of has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars: and that

All submissions must contain a forwarding/covering letter under the Company/Firm's letter head paper bearing amongst others, the Registration Number (RC) as issued by Corporate Affairs Commission (CAC), telephone number, email and contact address and the company's bid price duly addressed to the Executive Chairman, NSUBEB.
