REQUIREMENTS:

(i) Verifiable and copy of certificate of Incorporation/Evidence with the Corporate Affairs Commission (CAC)

(ii) Verifiable evidence of Tax clearance for the last three years (2014, 2015 & 2016)

Note that turnover will be computed from paid tax in determination of financial strength.

Turn over for F1 should not be less than N30m.

Turn over for F2 and F3 should not be less than N10m.

(iii) Verifiable evidence of Certification from PENCOM in accordance with the Pension Reform Act, 2004 including evidence of remittance of Employee's Pension contributions/deductions

(iv) Verifiable evidence of Certificate of Compliance with Industrial Training Fund (ITF) contributions in line with the section 16 (6) (d) of the Public Procurement Act, 2007; (v) Verifiable evidence of registration with the Bureau of Public Procurement (BPP), National Data base of Contractors, Consultants and Service Providers in form of current Interim Registration Report (IRR).

(vi) Company Audited Accounts prepared by a Chartered Accounting firm for the last three years (2014, 2015 & 2016) showing annual turnover.

(vii) Verifiable evidence of payment for NSITF

Note: Presentation of the Certificate of IRR (Interim Registration Report) is a MUST.

(2) OTHER REQUIREMENTS:

- (viii) Verifiable evidence of Technical Capability.
- (ix) Verifiable list of similar jobs successfully executed in the last three years including letters of award of contracts, project costs, job completion certificates and payments (please provide contact address of the clients who may be contacted for reference)
- (x) Verifiable evidence of financial capability to execute the projects.
- (xi) Company profile and technical qualification/curriculum vitae of key personnel with evidence of experiences on similar jobs,
- (xii) Submission of relevant technical specification and detailed brochures of equipment being offered
- (xiii) A list of verifiable Equipment indication ownership or on lease for construction works only.
- (xiv) A sworn Affidavit that none of the Directors has been convicted in any court of law of any criminal offence.
- (xv) A sworn Affidavit confirming that all information presented and attached are true and correct of the Company and that no officer of the Federal Medical Centre, Umuahia or Bureau of Public Procurement, is a former or present Director, Shareholder or has any pecuniary interest in the bidder.

(3) BID DOCUMENTS:

Bid documents can be obtained from the Procurement Unit, Federal Medical Centre, Umuahia upon an evidence of payment of Twenty Thousand Naira (N20,000.00), only, non-refundable.

(4) SUBMISSION OF BIDS:

(a) Technical and financial bids should be enclosed in a sealed tapper proof envelope, indicating the lot at the top right head corner of the envelope addressed to:

(c) The document should be deposited in the tender box at the office of Head of Procurement, Federal Medical Centre, Umuahia. Company names should also be rewritten at the reverse side of the envelope, closing time for all submission is **on or before 12 noon prompt 4th September, 2017**. Late submission shall not be entertained.

(5) OPENING:

Opening of the received bids will commence at 12noon prompt **4th September, 2017** at Federal Medical Centre, Umuahia Board Room Floor 2nd Administration Complex. All bidders and/or their representatives, relevant Professional Bodies and NGO's are invited to witness the Public opening exercise accordingly.

All CAC, PENCOM, ITF, NSITF and TAX certificates may be referred to the security Agency, Corporate Affairs Commission, Federal Inland Revenue (FIRS), National Pension Commission and other relevant bodies for verification.

The Federal Medical Centre, Umuahia reserves strength to reject any or all the submissions that do not meet up with the requirements as specified.

The Evaluation of the received documents shall be strictly based on the requirements specified above.
