(iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31 December, 31 December, 2018;

(v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31 December, 2018;

(vi) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2019 or valid Certificate issued by BPP.

(vii) Sworn Affidavit:

disclosing whether or not any officer of the relevant committees of the University of Benin or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

That the company is not in receivership, insolvency or bankruptcy;

That the Company does not have any Director who has been convicted in any court in Nigeria or any other Country for criminal offence in relation to fraud or financial impropriety;

(viii) Company's Audited Accounts for the last three (3) years -2015. 2016, 2017;

(ix) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;

(x) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications;

(xi) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five
(5) years including Letters of Awards. Valuation Certificates, Job Completion Certificates and
Photographs of the projects;

(xii) Only companies included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorized representatives should bid for LOT 1a and 1b;

Completed Financial Bids shall be submitted in two hard copies versions in A4 sized paper, spiral bound, numbered serially and dully signed by authorized signatories in a sealed envelope and labelled "Financial Bid" with Bidders name at the top right corner. The Technical Bid and Financial Bid should be enclosed in a sealed third large envelope and boldly marked with the name of the bidder and project name.
