- (V) Evidence of-Financial capability and Banking support
- (VI) Experiences/Technical qualification and experience of key Personnel
- (VII) Similar projects executed and evidence of knowledge of the industry
- (VIII) Equipment and Technology Capacity.
- (IX) Annual Turnover
- (X) VAT Registration and evidence of Past VAT remittance.
- (XI) Certified Bank Draft of Fifty Thousand Naira, payable to the KADUNA STATE GOVERNMENT for each lot. Any LOT not accompanied with a draft SHALL not be considered
