- Evidence of financial capability and banking support backed by bank statement and audit reports.
- Verifiable evidence of previous experience in construction projects of similar magnitude (Attach Letters of Award and Certificates of Completion).
- Experience/Technical qualification of key personnel to be employed in the project, if awarded.
- Evidence of registration with PENCOM and Remittance of the required contribution to appropriate Pension Fund Administrators

- Evidence of certificate of compliance by industrial training fund in line with the provisions of ITF Act 2011.
