- (a) That bidders do not have any Director who has been convicted in any country for any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter;
- (b) Disclose whether or not any officer of the relevant committees of in Adeyemi College of Education is a former or present director, shareholder or has any pecuniary interest in the bidder, and;
- (c) Confirm that all information and documents presented in its bid are true, genuine and correct in all particulars.
- (viii) List of equipment to be used for the execution of the project listed as owned, hired or leased with evidence
- (ix) Company profile to include organizational chart (Organogram), curriculum vitae, contact details and copies of credentials of staff showing the company's experience and technical qualification of key personnel relevant to the project
- (x) Evidence of similar projects successfully executed with their location over the last five (5) year i.e. from 2012 to date by inclusion of verifiable letters of award and original copies of reference letters from three (3) clients on duly completed or on-going projects addressed to the Registrar
- (xi) Evidence of financial strength and bank support by inclusion of bank reference letter addressed to the Registrar and statement of account
