Invitation for Pre-Qualification for Needs Assessment Projects for 2013

1.0 Introduction

The Rivers State University of Science and Technology desires to execute some projects under the Needs Assessment Projects for the following:

- (i) Hostel Block Complex
- (ii) Quantity Surveying Block complex
- (iii) Offices and Laboratories for Institute of Pollution Studies

Consequently, competent and reputable registered Contractors are requested to forward their documents for purposes of **PRE-QUALIFICATION** and subsequent Tenders.

2.0 PROJECTS/SCOPE OF WORK

(A) HOSTEL BLOCK COMPLEX

This project involves the construction of two Storey Students Hostel to accommodate approximately 80 rooms and all ancillary support facilities and services.

(B) QUANTITY SURVEYING BLOCK COMPLEX

This project involves the construction of two Storey Departmental Office complex to house Offices, Laboratories, Conference rooms, Departmental Library, Classrooms and many others.

(C) OFFICES AND LABORATORIES FOR INSTITUTE OF POLLUTION STUDIES

This project will involve the construction of high level Laboratories, Offices, Conference Room, Departmental Library, Classroom and so on.

3.0 PRE-QUALIFICATION REQUIREMENTS

- (i) Collection and completion of University pre-qualification form with a non-refundable deposit of N150,000.00
- (ii) Certificate of Incorporation.
- (iii) Tax Clearance Certificate for the past three (3) years.
- (iv) Verifiable evidence of the existence of a functional office or location of business.
- (v) Verifiable evidence to show that Contractor has handled similar projects in the past.

(vi) Evidence of availability of competent and qualified staff and experienced professionals for the project.

4.0 GENERAL INFORMATION

(i) Interested, reputable, competent and registered Contractors in any of the above categories should:

Proceed to the office of the Director of Works to collect the **Clearance Certificate for participation.**

(a) Proceed to the Bursary Department with the Clearance Certificate and pay the non-refundable deposit of N150,000.00 (One Hundred and Fifty Thousand Naira only) through University's Point of Sale (POS)

(b) Obtain University official receipt from the Bursary Department before proceeding to the office of the Director of Works to collect the pre-qualification Form.

(ii) Completed pre-qualification forms and other documents should be submitted to the office of the Director of Works **on or before Wednesday 7th of July, 2016.**

(iii) After the pre-qualification exercise, the names of the prequalified Contractors will be published on the Notice Board of the Estate and Works Department.

(iv) Only prequalified Contractors for each project will be issued Tender documents.
