- The Company must have a professional Engineer with COREN certification (or higher), who is actively involved with the organization.
- Evidence of possession of a substantial proportion of equipment required to successfully execute the contract (where applicable) indicating ownership or lease. State location of the plants and equipment for ease of verification.
- Audited company account for the last three (3) year i.e. (2011, 2012 and 2013)
- Evidence of financial capability with Sank reference letter indicating accessibility to credit facilities with maximum amount stated.
- Irrefutable/concrete evidence of financial capability to execute and complete the project.
- Bank statements of account for the last three months and letter authorizing fire Board to verify same from the bank.
- Evidence of performance on similar verifiable and successfully executed projects in the last three years (2011 2013) starting, clients, location, letters of awards cost with completion certificates and photographs attached.
- A sworn affidavit that none of the directors have been convicted in any country for any criminal offence inducting fraud or financial impropriety.
- · Quality assurance control manuals for the company.
- Any other document that may place your company on comparative advantage.
