Invitation for Pre-qualification (Corrigendum)**

The Chukwuemeka Odumegwu Ojukwu University (COOU) formerly Anambra State University invites bids for prequalification and tender/bidding (as earlier advertised on Monday August 24, 2015 in the Federal Tenders Journal) from interested reputable and competent contractors for the construction of the following projects under the NEEDS Assessment of Nigeria Public University Special Presidential Intervention Phase I and II as follows

Phase I

- (a) Rehabilitation/Renovation of Hostels
- (b) Rehabilitation/Renovation of Lecture Rooms
- (c) Rehabilitation Renovation of Laboratories and Libraries
- (d) Construction of new Lecture Theatre and Lecture Rooms
- (e) Construction of Laboratories and Libraries

Phase II

- (a) Construction of Lab/Studio/Workshop
- (b) Construction of Staff offices
- (c) Construction of Seminar Rooms/Auditorium
- (d) Installation of Municipal Services: Solar Street Lighting
- (e) Construction of Recreational facilities (Foot Ball Sports Field).

Requirements:

Competent and interested contractors and suppliers who have requisite experience, equipment and plants and desire to execute the project(s) are required to submit their firm's profile which must include but not limited to the following documents;

- (i) Evidence of incorporation of the company with Corporate Affairs Commission (CAC).

- (ii) Evidence of compliance Certificate with Industrial Training Fund (ITF) Act No 19 of 2011
- (iii) Evidence of current Company tax clearance certificate for the past three years (i.e 2012, 2013, 2014)
- (iv) Evidence of VAT certificate and VAT (remittances to Federal Inland Revenue Service: (FIRS).
- (v) Evidence of Contractor's Registration in the Bureau of Public Procurement' National Data Base of Contractors, consultants and Service Providers.
- (vi) Evidence of previous similar projects undertaken in past five (5) years including verifiable scope: of project, site of project, contract sum, evidence of successful completion of such project in record time (showing interim final valuations and payment certificates).
- (viii) Evidence of current audited account of firms for the past Three (3) Year (2012, 2013, 2014).
- (ix) Evidence of possession of plants and equipment and a listing of such equipment as possessed/owned or easily accessible by the firm, state location of plants and equipment for ease of verification.
- (x) Evidence of Financial capability and banking support (bank references), bank statement of accounts for last three months and letter authorizing the University to verify same from the bank.
- (xi) Sworn affidavit that (a) Firm is not bankrupt (b) none of the Directors is an ex-convict or bankrupt.
- (xii) Evidence of current Pension clearance certificate from PENCON
- (xiii) Please state clearly your company's address, GSM Phone number and email address for easy communication.

Method of Application

All applications should be packaged in the listed order (i- iii) above, Eligible Companies /Firms who desire to be pre-qualified for these projects are required to prepare and submit their pre-qualification documents in ONE (1) hard copy and ONE

(1) soft copy in a sealed envelope clearly indicating on the top the chosen description/scope of work as well as the code of the chosen lot and addressed to:

Deadline for Submission

Pre-qualification documents should be registered and thereafter dropped into the Tender Box at the Registrar's Office Chukwuemeka Odumegwu Ojukwu University, Igbariam Campus **not later than 4pm, 10th November, 2015**. Pre-qualification documents shall be opened **on 12th Nov. 2015 at 11.00 am** in the Council Chamber of the Igbariam Campus of the University. All Contractors/Firms will be notified of the pre-qualification result in writing. Successful and pre-qualified contractors shall thereafter be invited to collect the tender and bid documents from the Director of Physical Planning, Chukwuemeka Odumegwu Ojukwu University, Igbariam Campus. While returning respective tender documents, the tenderers/bidders shall be required to pay the stipulated Non- Refundable tender fee of N80,000.00 (Eighty thousand naira only) in Ecobank, Fidelity Bank or Zenith Bank and obtain certified Bank Teller and convert the Bank Teller into a receipted evidence of payment from the Revenue Unit of the University Bursary. Certified ten copies of the receipts of all payments must be attached.

The completed tender documents should be returned **not later than 15th December, 2015 at 4.00pm**. Opening of Tenders shall be held **on Thursday 17th December, 2015 all 11.00am** in the Council Chamber of the University at Igbariam Campus.
