## **2.0 Pre-qualification Requirements**

### **2.1 Mandatory Requirements**

#### **Prospective bidders are required to submit the following documents**

- (i) Certificate of incorporation/Registration with Corporate Affairs Commission (CAC) & Form CO7:
- (ii) Evidence of registration on the National Database of Contractors, Consultants and services Providers with the Bureau of Public Procurement (BPP)
- (iii) Evidence of compliance with Pension Reform Act, 2004 by inclusion of PENCOM compliance certificate
- (iv) Evidence of Tax clearance certificate (2013, 2014 and 2015)
- (v) Evidence of Compliance with Industrial Training Fund (ITF) amendment act 2011

**Note: Non-compliance with any of 2.1 (i-v) above shall lead to disqualification**

## **2.2 OTHER REQUIREMENTS**

- (i) Evidence of VAT registration and remittances.
- (ii) Detail company profile and organogram including names, and phone no. of key personnel (Technical/Managerial).
- (iii) Possession of experience as prime contractor in at list five (5) projects of similar nature and complexity with certifiable letters of contracts award and certificates of job completion within the last five (5) years
- (iv) Evidence of financial capabilities/Reference letter from a reputable Bank and Statement of accounts.
- (v) Bidders are to provide evidence of ownership/lease of relevant construction equipment
- (vi) Duly certified company audited account (with company seal) for the last three (3) years
- (vii) Sworn affidavit in line with provision of Part IV section 16 sub-section 6 (i) of the BPP Act, 2007 stating that all documents/Information presented are genuine and verifiable
- (viii) The Director (s) of me firms has/have never been convicted in any court of law within or outside Nigeria
- (ix) None of the officers of Federal University Dutsinma or BPP is a former or present Director/ Staff of the company.
- (x) The Company is not in receivership

### **3.8 Submission of Completed Technical Pre-Qualification Bid Documents**

Pre-Qualification Documents should be submitted in an envelope clearly marked “**PRE-QUALIFICATION TO TENDER**”“ **Lot No.** (Indicate the Lot No. for the bid), Payment of Non-refundable pre-qualification processing fee of Twenty Thousand Naira (N20,000. 00) only is required for each lot (Payment fow each Lot should be made to Federal University Dutsin-ma TSA Account via Remita). All envelopes should also clearly bear the name of the company/firm with the Project Title, boldly written at the top left hand corner Completed pre-qualification documents should be addressed and submitted to
