(g) VAT registration and evidence of post VAT remittances.

(h) Evidence of similar and verifiable projects executed and completion certificate(s) or interim valuation certificate (and not just award letter(s) within the last five (5) years.

(i) Evidence of registration of key professional staff with professional bodies as at 2014.

(j) Sworn Affidavit that none of its directors has been convicted in any country for financial matters,

(k) Sworn Affidavit indicating that all documents submitted are genuine and verifiable.

(I) Evidence of Financial Capability and banking support and Statement of Account for the last 12 months.

(m) Annual Turnover (must be the same in both TCC and Audited Reports),

(n) Comprehensive Company Profile and Organizational Structure.

#### 3.0 Scope of Work

(i) Procurement of various assorted books titles and e-books/journals

(ii) Procurement of computers, electronic bill boards, projectors, computer accessories/software and other office equipment

(iii) Procurement of security gate and scanners

(iv) Procurement of Library bookshelves and bindery equipment
