- (iv) A copy of the company's audited accounts of the preceding three years.
- (v) Evidence of current tax clearance certificates for 2013, 2014 & 2015 corresponding with cleared annual Turnover by inclusion of photocopy.
- (vi) Current evidence of compliance (Registration and Remittance) with the provision of the Pension Reform Act 2004.
- (vii) Evidence of financial capability/ banking support to handle the project.
- (viii) Verifiable evidence of projects successfully executed in Nigeria.
- (ix) Verifiable evidence of experience and relevant qualifications of key personnel
- (x) Evidence of compliance with the Industrial Training Fund Amendment Act 2011.
- (xi) Evidence of Registration/Renewal with Federal Medical Centre Nguru.
