PRE-QUALIFICATION REQUIREMENTS

- Evidence of registration with the Corporate Affairs Commission (CAC)
- Current Tax Clearance Certificate (TCC) for the past three (3) years 2013, 2014 and 2015 from the Federal Inland Revenue Service (FIRS).
- Value Added Tax (VAT) Registration Certificate and evidence of VAT remittances in the last three (3) years (2013, 2014 and 2015).
- Verifiable evidences of past job experience in similar jobs of interest in the last five (5) years or currently being executed such as letter of Award, job completion certificate and evidence of payment.
- Comprehensive company profile including the Curriculum Vitae of key personnel.

- Bank Accounts details and Letter of Reference from a Bank indicating evidence of accessibility to credit facilities MUST be submitted.
- Evidence of Ownership of equipment for Civil works or evidence of stock for supply of reagents/chemicals, laboratory equipment, library books and generator
- Evidence of compliance with the provisions of section 6 (1) of Industrial Training Fund (ITF) Act on 1 % contribution of every employer having 5 or more employees in his establishment (Registration and Remittances).
