All documents must be submitted **on or before 12 noon on 12<sup>th</sup> September, 2016** to the office of the Principal FGGC Tambuwal.

### **BID OPENING**

Bids will be opened immediately after the closing of submission on the same day at the School's Conference Room. Late submission will not be entertained.
