- Verifiable evidence of Interim Registration Report (IRR) from the Bureau of Public Procurement (BPP) Federal Contractors, Consultants and Suppliers Database;
- Verifiable evidence of financial support from a reputable Bank
- Verifiable evidence of National Social Industrial Training Fund (NSITF) Certificate;

- Verifiable evidence of Company profile and Technical Qualification of Key Personnel with registration with relevant professional bodies;
- Verifiable evidence of letters of award and job completion certificates of previous experience in similar job(s) at least three (3) in the past three (3) years;
- A Court Affidavit stating that all information are true and correct and that none of the Company Directors have been convicted of any crime relating to fraud and also that none of the Directors is a staff of the Ministry of Education or Bureau of Public Procurement;
- Verifiable evidence of construction equipment with proof of ownership or lease agreement
- Verifiable evidence of payment of a non-refundable tender fee of ₦20,000.00 to be paid to the School's TSA Account (FSTC Zuru TSA No.: 0340470661017) through Remitta Platform.
