#### **(1) Introduction**

Federal Government Girls' College, Gboko Benue State, intends to carry out procurement of works and services under the 2016 Budget Appropriation in compliance with the requirements of the Public Procurement Act 2007.

(2) The College invites interested, reputable and qualified contractors, suppliers and consultants with relevant experiences and good track records necessary for the execution of these projects.

#### **(2.1) SCOPE OF WORK**

Lot 1: Renovation and Rehabilitation of Technical Drawing Block

Lot 2: Reticulation of Water in the Hostels and Admin Block.

Lot 3: Computerisation and Provision of Internet Services to Admin Block.

Lot 4: Supply and Installation of 1No. Transformer.

#### **(3) ELIGIBILITY REQUIREMENTS**

Prospective bidders are required to submit the following documents:

- (i) Verifiable evidence of registration with Corporate Affairs Commission (CAC).
- (ii) Verifiable Tax Clearance for the last three (3) years: 2013, 2014 and 2015.
- (iii) Verifiable current Pension Compliance Clearance Certificate 2016 from Pension Commission (PENCOM).
- (iv) Verifiable current Industrial Training Fund (ITF) Clearance Certificate 2016.
- (v) Verifiable Current National Social Insurance Training Fund (NSITF) Clearance Certificate 2016.
- (vi) Verifiable evidence of registration with the Bureau of Public Procurement (BPP), Federal Contractors, Consultants and Suppliers data base.
- (vii) Verifiable evidence of financial support from a reputable bank.
- (viii) Company profile and verifiable evidence of Technical Qualification of key personnel including registration with relevant professional bodies.

- (ix) Letter of award and job completion, Certificates of verifiable previous experiences in at least three (3) similar jobs in the last five (5) years.
- (x) Verifiable evidence of construction equipment with proof of ownership or lease agreement.
- (xi) Verifiable evidence of payment of a non-refundable Tender fee of twenty (N20,000.00) naira to Federal Government Girls' College, Gboko Remita Account.
- (xii) Verifiable current registration certificate with Financial Reporting Council of Nigeria three (3) years audited report.
