- (c) Contractor's Current Tax Clearance Certificate and VAT Registration Certificate/Evidence of remittance;
- (d) Evidence of recent experience and proven track record in similar projects;
- (e) Evidence of capacity and facilities for engineering, manpower, Assembly, testing, local content.
- (f) List of Plants, Equipment and Technical Staff available for the project.
- (g) Membership of Professional bodies by key personnel.

(3.2) Financial Bids must satisfy the following criteria:-

(a) Evidence of sound financial status;

(b) Acceptable proposal for project execution;

(c) Acceptable cash flow programme and projections for the duration of the

project;

(d) Bank references from a reputable Bank.

(3.3) Technical Proposals will first be assessed to determine eligible Contractors.

Bids not considered eligible at the assessment stage shall be rejected without further

recourse to the financial proposal which shall be duly returned to such Contractor

unopened.

(3.4) The financial Proposal of the Contractors who meet the minimum Technical

Criteria shall be opened in public without any prior discussion or explanations

between the Contractors and the employer.

(4) Visit to site:

Contractors are advised to visit the site to assess the scope of work before submission

of their completed Tender Documents.
