(B) Pre-qualification Requirements

To be considered, potential Companies are required to submit all the under listed documents:

- (i) Certificate of incorporation of the company with the Corporate Affairs Commission
- (ii) Tax Clearance Certificate for the last three (3) years
- (iii) VAT Registration Certificate
- (iv) Company Audited Accounts for the last three (3) years
- (v) Verifiable previous jobs executed giving names of Client, contract sum and practical completion evidence
- (vi) Bank reference and copies of current bank statements
- (vii) Evidence of compliance with Pension Reform Act, 2004. (Certificate of Compliance)
- (viii) Evidence of Compliance with Industrial Training Fund (ITF) Provision
- (ix) Company's registered address, functional contract address, GSM Phone number(s) and e-mail address(es).

A sworn Affidavit by a Director certifying that;

- (a) The documents submitted for the pre-qualification exercises are genuine and correct
- (b) None of the Director(s) of the Company had ever been convicted by Law
- (c) The Company is not bankrupt
- (d) None of the Officers of the University of Ilorin is a present or former Director of the Company.

(x) Please, note that the originals of documents would be requested and, therefore, should be made available for sighting whenever required. The opening of the bids follows immediately after close of submission.

(xi) Payment of non -refundable Processing fee of N10,000.00 per lot with evidence of Payment accompanying the Bidding documents.

(C) Tender Procedure

(1) The suppliers/contractors are required to prepare and submit their tenders in two (2) separate pans, namely:

(i) Technical tender (Pre-qualification)

(ii) Commercial/Financial Tender

(2) Bids shall be prepared and submitted in accordance with the aforementioned Tender documents. In the event of a contract award, the bidder will be required to enter into formal contract agreement in the form of and based on the proposed contract documents.

(D) Submission of Tender

Interested bidders are expected to put the technical bid in a separate scaled envelope and financial bid in another sealed envelope. Each envelope should be distinctively labelled to indicate its nature.

The two (2) envelopes should be put together in a bigger sealed envelope, indicating Company's Name, Particulars and Name of the Lots, in line with the three (3) envelopes system of tendering.

Envelopes for each Lot should be clearly marked as may be applicable. It should be forwarded to:
