- (IV) Evidence of compliance with industrial training fund Act
- (V) Certificate of compliance with pension act.
- (VI) Audited account of the company for recent 3years
- (VII) Recent 3years tax and VAT registration
- (VIII) Letter from the company's Bank stating its financial capability.
- (IX) Evidence of Company registration in the National Database of Federal contractors. Consultants and service providers (NDCCSPS)

**(B) SUBMISSION**

- (I) Contractors/Suppliers shall enclosed the original and 2 copies of the technical/Financial bids each in a separate sealed envelope, duly marking the envelopes as "TECHNICAL/FINANCIAL BIDS" for both the ORIGINAL" and COPIES, as appropriate and bearing the name and address of the contractor.
