- Verifiable evidence of certificate of registration with Corporate Affairs Commission (CAC).
- Verifiable evidence of Tax Clearance Certificate in the last three years (2013,2014 and 2015).
- Verifiable evidence of current Pension Commission (Pencom) Compliance clearance certificate (2016).
- Verifiable evidence of current Industrial Training Fund Certificate (ITF) (2016).
- Verifiable evidence of Compliance with Registration with National Social Insurance Trust Fund (NSITF).
- Verifiable evidence of registration with the Bureau of Public Procurement (BPP) Federal contractors, consultants and suppliers Database in the form of current Interim Registration Report (IRR).
- Verifiable evidence of financial support from a reputable Bank.
- Verifiable evidence of letters of award and job completion certificates of previous experience in similar job(s) at least three (3) in the last five years.
- Verifiable evidence of construction equipment with proof of ownership or lease agreement.
- Verifiable evidence of company profile and technical qualification of key personnel with registration with relevant professional bodies.
- Verifiable evidence of registration with Financial Reporting Council of Nigeria.
- A sworn affidavit confirming that all information presented and attached are true and correct, that the company is not in receivership, insolvent or bankrupt and none of its Directors was ever convicted by any court of law or staff of the Federal Ministry of Education (FME) or BPP.
- (xi) Verifiable evidence of payment of a non-refundable tender fee of N20,000.00

N.B: The above listed requirements shall form part of the Evaluation criteria and non- compliance with any of the stated conditions shall result in automatic disqualification of the bidder.
