(1.0) Introduction

Federal Government Girls College Billiri, hereby invites interested, competent and qualified contractors to tender for any of the Capital Projects for 2016 at Federal Government College Billiri, Gombe State.

SCOPE OF WORK

LOT 1: Purchase of Computers, UPS, Printers and Scanners

LOT2: Renovation of 3Nos Girls' Hostels for 140 Students

LOT 3: Renovation of 3Nos Boys' Hostels for 130 Students

LOT4: Construction of 1No Girls' Hostel for 200 Students

LOT 5: Completion of 1 No Clinic Complex

LOT 6: Completion of 1 No Technical Workshop

(2.0) TENDERS REQUIREMENT

Prospective Bidders are required to submit the following documents:

- (1) Evidence of incorporation with Corporate Affairs Commission (CAC)
- (2) Evidence of Tax Clearance Certificate for last (3) Three years (2013, 2014 and 2015)
- (3) Evidence of PENCOM Certificate Registration in accordance with Pension Reform Act, 2004, including current Evidence of remittance of employees pension contributions/deductions for Dec. 2016.
- (4) Evidence of Interim Registration Report from Bureau of Public Procurement (BPP) Data Base of Contractor, Consultant, Supplier.
- (5) Evidence of verifiable experience or last (3) three years similar project executions in last five years, giving names of client, contract sums and evidence of practical completion.

- (6) Evidence of financial capability and Banking support.
- (7) Evidence of payment of training of contribution to ITF in compliance with ITF amended Act, 2016
- (8) Evidence of remittance to Social Insurance Trust Fund (NSITF) copy of compliance certificate expiring 31st Dec. 2016
- (9) Company audited Account for last three (3) years (2013, 2014 and 2015)
- (10) Company Profile to include among others; office address, current telephone number(s) and email address, evidence of technical and professional qualifications, technical personnel and their qualifications
- (11) Verifiable current Certificate of Registration with Financial Reporting Council of Nigeria Dec. 2016.
- (12) Verifiable evidence of Construction Equipment with proof of ownership or lease agreement
- (13) Sworn Affidavit from competent court that all documents submitted are not only current but genuine. That the Director has never been convicted by any court of law.
- (14) Verifiable evidence of payment of non- refundable Tenders fee.
- (15) Maximum bidding is two (2) per company.

N.B:

The above listed requirements shall form part of the bid evaluation criteria and non-compliance with any of the stated conditions shall result in automatic disqualification of bidder.
