- (iii) Tax clearance receipt/certificate for the last three (3)years (2013-2015)
- (iv) Evidence of Vat registration with Tin NO and past Vat remittances
- (v) Evidence of compliance with pension reform act 2004.
- (vi) Audited accounts for the last 3 years (2013-2015)
- (vii) Evidence of current Industrial Training Certificate (ITF) clearance certificate (2016).
- (viii) Company profile including qualification and individual experience of key staff.
- (ix) Evidence of similar jobs executed including copies of letters of award and practical Completion certificate
- (x) Evidence of compliance with Registration with National Social Insurance Trust Fund (NSITF).
