**ELIGIBILITY REQUIREMENTS**

Interested contractors are required to submit the following documents:

- (1) Verifiable evidence of Certificate of registration with Corporate Affairs Commission (CAC)
- (2) Verifiable evidence of Tax Clearance Certificate in the last three years (2013, 2014 and 2015)
- (3) Verifiable evidence of current pension commission (PenCom) compliance clearance certificate (2015)
- (4) Verifiable evidence of compliance with National Social Insurance Trust Fund (NSTIF)
- (5) Verifiable evidence of financial support from a reputable bank.
- (6) Verifiable evidence of letters of award and job completion certificates of previous experience in similar job(s), at list three (3) in the last five years.
- (7) Verifiable evidence of equipment with proof of ownership or lease agreement
- (8) Verifiable evidence of a non-refundable tender fee of N 20,000.00
- (9) Verifiable evidence of company profile and technical qualification of key person with registration with relevant professional bodies.

(10) A sworn affidavit confirming that all the information presented and attached are true and correct, that the company is not in receivership, insolvent or bankrupt and none of the directors was ever convicted by any court of law or staff of Federal Ministry of Education (FME) or BPP.

### **COLLECTION OF TENDER DOCUMENTS**

The bids should be dropped in the Tender Box at the office of the principal, F.S.C Ogoja. Bidders are to ensure that they also sign the submission register.
