## (B) ELIGIBILITY REQUIREMENTS

- (ii) Tenders must be accompanied with the following eligibility and qualification information/documentation to demonstrate possession of the human, technical and financial capacity required to carry out the Project Package tendered for: –
- (a) Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and Form CAC7.

- (b) Tax Clearance Certificate for the last three (3) years valid till 31st December 2020, with minimum average annual turnover as follows: –
- Package A-N70 million
- Packages B A C-N25 million
- Package D-N50 million
- Packages E & F-N10 million
  - (c) Evidence of current Pension Compliance Certificate valid till 31st December 2020.
  - (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2020.
  - (e) Evidence of current Nigerian Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December 2020.
  - (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service providers by submission of Interim Registration Report (IRR) expiring on 1st January 2021 or valid certificate issued by BPP.
  - (g) Evidence of registration with Kaduna State Public Procurement Authority valid till 31st December 2020.
  - (h) Evidence of registration with Kaduna State Ministry of Business Innovation & Technology valid till 31st December 2020.
  - (i) Company's audited accounts for the last three years (2017,2018 & 2019).
  - (j) Verifiable evidence of having executed at least three (3) projects of a nature and complexity similar to the proposed work in the last five (5) years, including award letters, completion certificates and/or photographs of the project, accompanied by full client contact Information and authorization for SUBE B to seek references.
  - (k) Evidence of financial capability to execute the project including reference letter from a licensed reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

- (I) List of plant/equipment available for deployment on the project with evidence of ownership/lease (MOU or receipt or invoice of purchase).
- (m) Company profile with complete curriculum vitae of key staff to be deployed on the project, detailing their experience and expertise relevant to the assignment, current contact information (telephone nos., email address), and copies of academic qualifications, professional registration certificates and current practice licenses.
- (n) High court affidavit deposed as below described and property addressed to Kaduna SUBEB (any Affidavit that predates this advert or addressed to other organizations will be rejected):
- disclosing whether or not any officer of Kaduna State Bask Education Board, Kaduna State Public Procurement Agency or the project consultants is a former or present Director, Shareholder or has any pecuniary interest in the Tenderer and attesting that all information presented in its bids are true and correct in all particulars
- affirming that none of the directors of the firm has been conducted of any criminal offence relating to fraud, financial Impropriety, falsification or acts similar in nature and to state that all documents used for this bidding are genuine;
- affirming that the Tenderer is not subject to any claim, arbitration or other litigation cases OR all claims, arbitration or other litigation cases have been satisfactorily resolved, and if not, they shall have no serious negative impact on the financial capacity of the Tenderer; and affirming that the Tenderer has not been declared ineligible for public financed contracts by the Federal Government of Nigeria or the Kaduna State Government.
