(i) List of verifiable documentary evidences of at least two (2) to similar jobs successfully executed within the last five (5) years including letters of awards and job completion Certificate.

(j) Company profiles to include names, qualifications (Including copies of relevant academic/professional qualifications) and experience of key personnel.

(k) Evidence of Financial Capability from a reputable Bank/Letter of Commitment from bank (1) For Joint Venture (JV) partnership, Memorandum of Understanding (MOU) should be provided.
