Interested bidders are expected to put the technical bid in separate sealed envelope and financial bid in another sealed envelope, with each envelope distinctively labeled as 'technical hid" and financial bid" respectively, while the two envelopes will be put in a third sealed envelope in line with the three envelopes system of tendering.
