2.0 Scope of Work

Lot 3: Procurement of brand new 2013 Toyota Coaster Bus with 30 passengers seater and 3 years warranty

Lot 3: Procurement of brand new 2013 Toyota Hiace Bus with 18 passengers seater and 3 years warranty

5. Evidence of execution of similar projects, stating clearly the location of the projects, including copies of letters of award and completion certificates.
6. Company audited accounts for the last three years
7. Annual Turnover
8. Evidence of financial capability and banking support
9. Evidence of company's commitment to staff on NHIS and Pension contributions
10. All evidence of compliance with relevant government rules concerning contract bidding
